Call to Order: Alyssa P. Lyon

Review and Reorder the Agenda: Unanimously approved reordering the hearing's agenda.

Review Conference Call and Continuance: Alyssa P. Lyon reviewed and disclosed for the record the occurrence and purpose of an executive session held by the Board between the July 11, 2018 hearing and the October 10, 2018. Chair Lyon reviewed and disclosed for the record the Board's decision between the July 11, 2018 hearing and the October 10, 2018 hearing to continue upon appellant counsel's request to October 10, 2018, the appeal hearing scheduled for August, 2018, in Case Number: 8-2018.

Review and Approval of Minutes from Previous Hearing: The board unanimously approved the Minutes from the July 11, 2018 meeting with the correction of the spelling of Alyssa P. Lyon's last name.

Appeals: 8-2018: 330 Mathews and 0 Logan Alley. IPMC 302.2 Grading and Drainage. Prior to proceeding on the merits, the parties, their counsel, and the Board agreed that the notice of appeal and the hearing would cover both 330 Mathews and 0 Logan Alley. Attorney Andrew Gross, counsel for Joseph Novakowski, the appellant, presented legal argument and testimony disputing violations O-1252486 and O-1270892. Attorney Emily McNally, counsel for PLI, and Michael Pro, the PLI inspector who issued the violations, presented photographs, documentation, testimony, and legal argument in favor of upholding the violations. The parties disagreed over the responsibility for and ownership of certain land and the trees thereon that were at issue. The Board took the case under advisement and deliberation. After advisement and deliberation, the Board has overturned the violations.

- Sarah Kinter, Assistant Director, Licensing and Administration, for PLI, provided various updates regarding PLI.
- Wesley S. Speary, Code Enforcement Officer for PLI, discussed and will follow up with scheduling training for the Board on Pennsylvania's Sunshine Act.
