**1.0 POLICY OR PURPOSE**

1.1 It is the policy of the Pittsburgh Bureau of Police to provide a smoke-free work environment for its members and employees and to conform with Section 617 of the Pittsburgh Code. The following regulations governing cigarette, cigar, and pipe smoking and chewing/smokeless tobacco, E-cigarettes, vapor products and Electronic nicotine delivery system (ENDS) shall apply to all members of the Pittsburgh Bureau of Police, to include police, civilians, staff and visitors.

**2.0 BUREAU OF POLICE DUTY LOCATIONS**

- 2.1 All Bureau of Police duty locations shall be established as "NO SMOKING" areas including desk areas, roll call rooms, restrooms, locker rooms, offices, garages, entryways and all other enclosed spaces that are either public areas or are permanently occupied by two or more persons.
- 2.2 The use of chewing/smokeless tobacco is prohibited in all Bureau of Police duty locations. This includes desk areas, roll call rooms, restrooms, locker rooms, offices, garages, entryways and all other enclosed spaces that are either public areas or are permanently occupied by two or more persons.

**3.0 BUREAU OF POLICE VEHICLES**

3.1 All employees of the Pittsburgh Bureau of Police are prohibited from smoking, using chewing/smokeless tobacco, vape and etc. in any police vehicle.

**4.0 SMOKING OR USE OF CHEWING/SMOKELESS TOBACCO WHILE IN UNIFORM**

4.1 Employees shall not smoke, vape and etc. or use chewing/smokeless tobacco while in uniform on any public street, at public functions or in any other public place while in direct contact with the public except during meals and rest periods, providing that use is done in accordance with City ordinances and in compliance with Bureau policy.
