## 1.0 Purpose

1.1 The purpose of this General Order is to establish guidelines and procedures to aide and facilitate the safe apprehension of any suspect who flees from a Pittsburgh Bureau of Police officer on foot and to prevent injury.

### 2.0 Policy

- 2.1 Whenever an officer decides to engage, or continue to engage, in a foot pursuit, a quick risk assessment must take place.
- 2.2 Officers must evaluate the risk involved to themselves, to other officers, the suspect and the community versus what would be gained from pursuing the suspect.
- 2.3 A foot pursuit will constitute a priority assignment to which available units will respond, as saturation of the area with officers is a proven technique in successfully ending a foot pursuit.
- 2.4 Bureau of Police Supervisors shall be responsible for reviewing the tactical soundness of foot pursuits when they occur.

### 3.0 Definitions

- 3.1 <u>Foot Pursuit</u>: A situation in which an officer, on foot, chases a suspect in an effort to detain or arrest that individual when reasonable suspicion exists that a crime is about to be committed, is being committed or has been committed and the suspect is resisting apprehension by fleeing from the officer.
- 3.2 <u>Suspect</u>: Includes any individual who a police officer reasonably believes is about to commit, is committing or has committed an offense or poses an immediate threat to the safety of the public, other officers, or themselves.

#### 4.0. Procedure

4.1 Factors to Consider when initiating a foot pursuit:





- 4.2 The decision to initiate or continue a foot pursuit requires weighing the need to apprehend the suspect against the degree of risk to which the officer and others are exposed as a result of the pursuit.
- 4.3 If possible, officers should consider the feasibility of the following strategies or tactics prior to initiating foot pursuits:



- 4.4 Once the foot pursuit has been initiated, the pursuing officer must notify police radio of as much of the following information as possible:
  - 4.4.1 Unit Identifier,
  - 4.4.2 Location,
  - 4.4.3 Direction of Travel,
  - 4.4.4 Description of suspect,
  - 4.4.5 If armed with a weapon,
  - 4.4.6 Reason for foot pursuit.
  - 4.4.7 Number of Suspects



4.6 Police Radio shall notify a supervisor of the pursuit circumstances and any other relevant information.



- 4.9 Officer(s) shall terminate a foot pursuit:
  - 4.9.1 When ordered by a Supervisor,
  - 4.9.2 When the officer believes that the danger to the pursuing officers or the public outweighs the necessity for immediate apprehension of the suspect.
  - 4.9.3 If the suspect's identity is known and he/she is not an immediate threat to the safety of the public or other officers, consider terminating the pursuit and apprehend at later date.
- 4.10 After termination of the foot pursuit, officers will notify Police Radio with the last known location of suspect or point of apprehension.

# 5.0 Supervisor Responsibilities

- 5.1 The role of the Pittsburgh Bureau of Police Supervisor is to monitor a foot pursuit and appropriately direct resources to safely apprehend the suspect.

- 5.4 The Supervisor shall terminate a foot pursuit at any time if it is determined the danger to the pursuing officer(s) or the public outweighs the necessity for immediate apprehension of the suspect(s).
- 5.5 Following each incident, debrief members involved and if feasible his/her shifts.
