1.0 **POLICY**

The Pittsburgh Bureau of Police (PBP) recognizes its responsibility to review requests and provide reasonable assistance for the personal protection of visiting dignitaries and other designated persons. Recognizing this responsibility, the Bureau will take reasonable precautions to assure the safety of such visitors.

NOVEMBER

1.2 Activities and duties of Pittsburgh Bureau of Police Detectives, Officers, and all personnel assigned to provide protection for individuals, groups, etc. who have been approved for dignitary protection services by the Chief of Police or his designee.

2.0 PURPOSE

- 2.1 The purpose of a security protection is to provide physical protection, identify potential threats, cyber threats, persons of interest, and all around safety and security for the designated person(s), their family, as well as any other personnel identified by the Chief of Police, or their designee.
- 2.2 It is the purpose of the PBP to provide security services where warranted, upon request, or dictated by the need for public safety involvement; but in all instances, to ensure public safety needs are met whether traffic and pedestrian concerns, motorcade, physical security of building or area occupants, crowd management for those exercising First Amendment privileges, as well as those opposed.
- The detail shall conduct themselves with the highest degree of dedication, integrity, and professionalism at all times, regardless of political affiliation or factors of group identity or classification.

3.0 **DEFINITIONS**

"Dignitary" refers to a person who may be a public figure, celebrity, or government official of a high rank or office.

PROCEDURES 4.0

- The Intelligence Unit will coordinate with others within the bureau, as necessary and appropriate, the requests for personal protection of the President of the United States, major political candidates, and other designated persons. All requests for assistance in protective services shall be forwarded to the Intelligence Unit.
- 4.2 The Intelligence Unit will review the request for protective services and consider if the request should be honored, based on such considerations as:
 - 4.2.1 Required bureau resources
 - 4.2.2 Potential for violence or disruption
 - 4.2.3 Existence of threats
 - 4.2.4 Nature and purpose of the visit
- 4.3 Each plan shall be developed in incident action plan format, and shall be made available to affected persons in a timely manner. Personnel will be provided briefing information consistent with their assignment.
